2019-2020 PAYMENT PLAN TERMS AND CONDITIONS

Our Payment plan has been a huge success for our customers in the past and we are continuing to improve our payment options in services such as the Snowschool Camps & Programs, the Kid's Rental Program and the New Super Early Bird and the Early Bird Season Passes.

The earlier you sign up for the plan, the longer the term and the lighter the payments.

The payment options are monthly installments for for the Super Early Bird with 5, 4 or 3 month of equalized payments or choose the Early Bird Season Passes with 2 equalized payments.

During June, the Payment Plan will be available. You can access and set up your payment account through our website www.poleymountain.com in the Season Pass Tab, or you can submit the application to our accounting department and we will set up the payment account for you. The payments must be paid in full by our early bird deadline November 2, 2019. The Super Early Bird Season Passes, The Kid's Rental Program and The Snow School Camps & Programs go on Sale July 1, 2019.

All season passes include a cost of \$17.25 hst included for Poley Sure Insurance unless you choose to opt out of it. All Season Passes purchased after November 2, 2019 must be paid in ONE LUMP SUM at the regular rates.

The Super Early Bird Season Passes will be available through the Payment Plan with the exception of the Corporate Season Pass.

The Snow School Camps & Programs are available through the Payment Plan with the exception of Private Lessons which need to be booked ahead of time.

The Kid's Rental Program will be available through the Payment Plan. This services is for children 12 and Under, you fit your children by the appointed dates in the upcoming fall and take your rental equipment home for the season.

Terms and Conditions:

To take advantage of the Payment Plan, Please fill out the 2019-2020 Payment Plan Customer Application (on reverse side) as well as the registration forms for the services you wish to set up.

Please Note the following: Payments must be made by Visa, MasterCard, Post Dated Cheques or through Web store PayPal Account. Cash and Money Orders will not be accepted for this service.

You must fill out all necessary information through Web store PayPal Account Online application and submit your registration forms or allow for one of our department managers to contact you in September.

If you choose to have the accounting department set up your account for you, you must make sure all information submitted is clear and complete before the deadline.

The options are: 5 Month Payment Term, 4 Month Payment Term, 3 Month Payment Term, 2 Month Payment Term or One Lump Sum to take advantage of this Service.

Please Note: If you choose to set up the payment option through PayPal: The first payment will be deducted automatically, and the following payments will occur on the same day of the next months until payment is made in full.

For Visa, MasterCard and Post Dated Cheque Users:

The online account must be set up by June 30, 2019
If you wish the accounting department to set up your account, the application must be submitted by June 30, 2019 to take advantage of the 5 month term.
The first payment will be deducted from your account on July 1, 2019, with the remaining 4 payments due August 1, September 1, October 1 and November 1, 2019.

4 Month Payment Term Included Super Early Bird Pricing, Snow School Programs & Kid's Rental Program
For the Months of August, September, October, and November 2019

The online account must be set up by July 31, 2019
If you wish the accounting department to set up your account, the application must be submitted by July 30, 2019 to take advantage of the 4 month term.
The first payment will be deducted from your account on August 1, 2019, with the remaining 3 payments due September 1, October 1 and November 1, 2019.

3 Month Payment Term Included Super Early Bird Pricing, Snow School Programs & Kid's Rental Program
For the Months of September, October, and November 2019

The online account must be set up by August 31, 2019.
If you wish the accounting department to set up your account, the application must be submitted by August 31, 2019 to take advantage of the 3 month term.
The first payment will be deducted from your account on September 1, 2019, with the remaining 2 payments due October 1 and November 1, 2019.

2 Month Payment Term Included Early Bird Pricing, Snow School Programs & Kid's Rental Program
For the Months of October, and November 2019

The online account must be set up by September 30, 2019.
If you wish the accounting department to set up your account, the application must be submitted by September 30, 2019 to take advantage of the 2 month term.
The first payment will be deducted from your account on October 1, 2019, with the remaining payment due November 1, 2019.

ABSOLUTELY NO REFUNDS WILL BE GIVEN UNLESS YOU PURCHASE POLEY SURE INSURANCE.
This applies to all Season Passes including those purchased on the Season Pass Payment Plan.

If you decide to discontinue with the payment plan after the payments have been received; no refunds will be issued without Poley Sure.

POLEY SURE INSURANCE:

Poley Sure is an insurance that protects your investment of a season pass. Poley Sure will guarantee a refund if you are unable to Ski or Snowboard due to injury, illness or job transfer. The cost for Poley Sure is \$15.00 plus HST and must be purchased at the same time you purchase your season pass and the coverage will be effective immediately.
